DECISION OF THE CONSTITUTIONAL COURT OF
THE REPUBLIC OF ARMENIA**

ON THE CASE OF CONFORMITY OF THE OBLIGATIONS STIPULATED IN THE SECOND ADDITIONAL FINANCING TO THE LIFELINE ROAD NETWORK IMPROVEMENT PROJECT LOAN AGREEMENT SIGNED BETWEEN THE REPUBLIC OF ARMENIA AND THE EUROPEAN BANK FOR RECONSTRUCTION AND DEVELOPMENT (EBRD) ON 10 OCTOBER 2019 WITH THE CONSTITUTION

Based on the review of the case and governed by clause 3 of article 168, parts 1 and 4 of article 170 of the Constitution, articles 63, 64 and 74 of the Constitutional Law on the Constitutional Court, the Constitutional Court **HOLDS:**

1. The obligations stipulated in the Second Additional Financing to the Lifeline Road Network Improvement Project Loan Agreement signed between the Republic of Armenia and the European Bank for Reconstruction and Development (EBRD) on 10 October 2019 are in conformity with the Constitution.

2. Pursuant to part 2 of article 170 of the Constitution this Decision shall be final and shall enter into force upon its promulgation.
