## IN THE NAME OF THE REPUBLIC OF ARMENIA DECISION OF THE CONSTITUTIONAL COURT OF THE REPUBLIC OF ARMENIA

ON THE CASE OF CONFORMITY OF THE LAWS ON MAKING AMENDMENTS AND SUPPLEMENTS TO THE LAW ON THE HIGHER EDUCATION AND SCIENCE ADOPTED ON 24 MARCH 2021 BY THE NATIONAL ASSEMBLY AND ADJUNCT LAWS ON EDUCATION, ON MAKING A SUPPLEMENT TO THE LAW ON FOUNDATIONS, ON MAKING AMENDMENTS TO THE LAW ON STATE NON PROFIT ORGANIZATIONS, ON MAKING AMENDMENTS AND A SUPPLEMENT TO THE LAW ON LICENSE, ON MAKING AMENDMENTS AND A SUPPLEMENT TO THE LAW ON STATE FEE, ON MAKING AMENDMENTS TO THE TAX CODE OF THE REPUBLIC OF ARMENIA, ON MAKING AN AMENDMENT TO THE CRIMINAL EXECUTIVE CODE OF THE REPUBLIC OF ARMENIA, ON MAKING AN AMENDMENT TO THE LAW ON MEDICAL AID AND SERVICE TO THE POPULATION, ON MAKING AMENDMENTS TO THE LAW ON ECOLOGICAL EDUCATION AND UPBRINGING, ON MAKING AMENDMENTS TO THE LAW ON ENERGY SAVING AND RENEWABLE ENERGY, ON MAKING AMENDMENTS TO THE LAW ON **RESCUE SERVICES, ON MAKING AMENDMENTS AND SUPPLEMENTS TO THE LAW ON** POLICE SERVICE, ON MAKING SUPPLEMENTS TO THE LAW ON THE APPROVAL OF THE POLICE DISCIPLINARY CODE OF THE REPUBLIC OF ARMENIA, ON MAKING AMENDMENTS TO THE LAW ON THE SERVICE IN THE NATIONAL SECURITY BODIES, ON MAKING AN AMENDMENT TO THE LAW ON THE STATUS OF MILITARY UNITS AND MILITARY INSTITUTIONS, ON MAKING AMENDMENTS AND SUPPLEMENTS TO THE LAW ON MILITARY SERVICE AND THE STATUS OF A SERVICEMAN, ON MAKING AN AMENDMENT TO THE LAW ON MEDICATION, ON MAKING AN AMENDMENT TO THE LAW ON STATE AWARDS AND HONORARY TITLES OF THE REPUBLIC OF ARMENIA, ON MAKING AN AMENDMENT TO THE LAW ON NOTARY, ON MAKING AMENDMENTS AND SUPPLEMENTS TO THE LAW ON STATE PENSIONS, ON MAKING AN AMENDMENT AND A SUPPLEMENT TO THE LAW ON LANGUAGE, ON MAKING A SUPPLEMENT TO THE LAW ON PROCUREMENT WITH THE CONSTITUTION ON THE BASIS OF THE APPLICATION OF THE PRESIDENT OF THE REPUBLIC

Based on the review of the case and governed by Clause 1 of Article 168, Clause 4 of Part 1 of Article 169, and Article 170 of the Constitution, as well as Articles 63, 64 and 79 of the Constitutional Law on the Constitutional Court, the Constitutional Court **HOLDS**:

1. To declare the Laws on Making Amendments and Supplements to the Law on the Higher Education and Science adopted on 24 March 2021 by the National Assembly and Adjunct Laws on Education, on Making a Supplement to the Law on Foundations, on Making Amendments to the Law on State Non Profit Organizations, on Making Amendments and a Supplement to the Law on License, on Making Amendments and a Supplement to the Law on State Fee, on Making Amendments to the Tax Code of the Republic of Armenia, on Making an Amendment to the Criminal Executive Code of the Republic of Armenia, on Making an Amendment to the Law on Medical Aid and Service to the Population, on Making Amendments to the Law on Ecological Education and Upbringing, on Making Amendments to the Law on Energy Saving and Renewable Energy, on Making Amendments to the Law on Rescue Services, on Making Amendments and Supplements to the Law on Police Service, on Making Supplements to the Law on the Approval of the Police Disciplinary Code of the Republic of Armenia, on Making Amendments to the Law on the Service in the National Security Bodies, on Making an Amendment to the Law on the Status of Military Units and Military Institutions, on Making Amendments and Supplements to the Law on Military Service and the Status of a Serviceman, on Making an Amendment to the Law on Medication, on Making an Amendment to the Law on State Awards and Honorary Titles of the Republic of Armenia, on Making an Amendment to the Law on Notary, on Making Amendments and Supplements to the Law on State Pensions, on Making an Amendment and a Supplement to the Law on Language, on Making a Supplement to the Law on Procurement contradicting Part 3 of Article 38 of the Constitution in part of Parts 3 and 4 of Article 27 of the Law of the Republic of Armenia on the Higher Education and Science.

**2.** Pursuant to Part 2 of Article 170 of the Constitution this Decision shall be final and shall enter into force upon its promulgation.
