ON THE CASE CONCERNING THE DETERMINATION OF THE ISSUE REGARDING THE CONFORMITY OF THE OBLIGATIONS STIPULATED BY THE TREATY ON COOPERATION OF STATE PARTIES TO THE TREATY ON COLLECTIVE SECURITY IN THE SPHERE OF DEVELOPMENT, PRODUCTION, OPERATION, REPAIR, MODERNIZATION, LIFE EXTENSION AND UTILIZATION OF MILITARY PRODUCTS SIGNED IN MOSCOW, ON 10 DECEMBER 2010, WITH THE CONSTITUTION OF THE REPUBLIC OF ARMENIA

Based on the review of the Case and being governed by Article 100, Part 2, Article 102, Parts 2 and 4 of the Constitution of the Republic of Armenia, Articles 63 and 64 of the RA Law on the Constitutional Court, the Constitutional Court of the Republic of Armenia **HOLDS**:

- 1. The obligations set forth in the treaty on cooperation of state parties to the treaty on the collective security in the sphere of development, production, operation, repair, modernization, life extension and utilization of military products, signed on 10 December 2010, are in conformity with the Constitution of the Republic of Armenia.
- 2. Pursuant to Article 102, Part 2 of the Constitution of the Republic of Armenia this decision is final and enters into force from the moment of its announcement.
