- 1. The obligations, stipulated by the Agreement on Air Communication between the Government of the Republic of Armenia and the Government of the Republic of Serbia signed on April 4, 2011 in Belgrade, are in conformity with the Constitution of the Republic of Armenia.
- 2. Pursuant to Article 102, Part 2 of the RA Constitution this Decision is final and enters into force from the moment of its announcement.
